Conventional Gravity Feed	1.6 – 1.8mm	40-45 psi

#### **SURFACE PREPARATION:**

Wash area with soap and warm water. Thoroughly clean area with Pre Clean. Sand area according to body filler manufacturer's recommendations. Reclean with pre-cleaner. For optimum adhesion and corrosion protection, bare metal surfaces should be coated with Self Etching Primer or Epoxy Primer before applying primer surfacer.

#### **APPLICATION:**

Apply 2-3 full wet coats of SMR-277NR Acrylic Lacquer Primer Surfacer using a good quality spray gun with a 1.6mm to 1.8mm tip. Allow a minimum of 5-10 minutes flash time between coats. Allow 30 minutes @ 70F (21C) air dry before sanding.

#### **SANDING:**

#### mobile refinish products

Allow SMR-277NR Acrylic Lacquer Primer Surfacer to thoroughly dry before sanding. Finish sand as follows:

320-400 grit sealer 320-400 grit single-stage system 400-500 grit basecoat
